

Privacy Policy

INTRODUCTION

This Privacy Policy applies to OTC Europe LLP, OTC Europe Holdings Limited, OTC Europe Services Limited, Oil Brokerage Limited, Oil Brokerage Services Limited, and Blue Commodities LLP – collectively, "OTC". We are committed to protecting the privacy of personal data, including personal data related to OTC clients and non-clients who contact us.

This Policy is specifically addressed to OTC clients and non-clients who contact us. It also applies to anyone who visits or uses our websites including <http://www.otcgh.com>, <https://www.oilbrokerage.com>, and <https://bluecommodities.com> (each a "Website"). This Policy sets out how we collect, store and use your personal data when visiting our Websites, instructing our brokerage services or by sending us communications.

I. **We are the Data Controllers in respect of your personal data:**

- **Blue Commodities LLP**, a limited liability partnership incorporated in England and Wales with company number OC387571, whose registered office address is 5th Floor, 10 Finsbury Square, London, EC2A 1AF.

OTC Europe LLP, OTC Europe Holdings Limited, OTC Europe Services Limited, Oil Brokerage Limited, Oil Brokerage Services Limited, and Blue Commodities LLP are registered as data controllers with the Information Commissioner's Office for the United Kingdom.

This Policy is written in accordance with the Data Protection Laws (which means the General Data Protection Regulation (GDPR) 2018, Data Protection Act 1998, Data Protection Act 2018, Privacy and Electronic Communications Directive (2002/58/EC), Privacy and Electronic Communications (EC Directive) Regulations 2003 (SI/2003/2426) and such other applicable privacy and data protection laws).

2. **How your data is collected:**

We collect personal data directly when you provide it to us. This may include data:

- provided during the OTC engagement process through our request for information and due diligence form;
- acquired as a result of any interactions you have with us, either in writing, by email, over the phone, or through our LinkedIn, Twitter or other social media accounts;
- collated from any networking event we have attended which has led to us making a new contact;
- gathered through web analytics (Google Analytics); and
- through the transactions we conduct on your behalf or in connection with services offered by OTC.

3. **We collect the following information from you:**

Information you give us:

- Name, email address, contact details and any communications you send to OTC;
- Data we have collated throughout our engagement process (request for information and due diligence form, for Anti-Money Laundering Purposes). This data may include:
 - your name and business address;
 - your business email address and phone number;
 - Company formation documentation
 - Identity verification documents, such as a passport or driving licence (For senior members of staff only inc. Board Members/CEO/Ultime Beneficial Owners).
- Details of any requests or transactions made through OTC on your behalf;
- We use Oracle as a third-party payment platform. This company will access and store your data in accordance with their privacy policies. This will store your name and business email address. The payment data you submit is collected on this platforms and used by OTC only; and
- Communication you send to OTC such as emails, telephone calls and letters.

Information we collect about you:

- Data about the ways people visit and interact with our Websites in the form of traffic analytics using Google Analytics. This includes IP addresses. You can opt out of being included in Google Analytics by emailing GDPR@otceuro.com or by writing to 5th Floor, 10 Finsbury Square, London, EC2A 1AF, or calling +4420 7726 8601 (9.30am to 5.30pm, Monday to Friday). For more information about the use of data analytics to protect and improve our services, please read Section 10 of this Policy.

We will only collect special categories of data where absolutely necessary. All data collected by OTC will be archived for a maximum of 7 years in accordance with the Financial Conduct Authority (FCA) Regulations, and then will be deleted after this time.

You may decline to provide us with your data, however, there are circumstances in which OTC cannot take action without certain of your personal data, for example, because this personal data are required to process your instructions or provide you with access to our services.

4. We and our service providers collect your personal data for the following purposes:

- Provide you with brokerage services, if you are or become a customer of OTC and/or deal with any requests or inquiries you may have;
- To collect data about what specific products entity(ies) you are buying and selling to create a user profile to personalize and foster the quality of our brokerage services and interaction with you;
- To better understand who is visiting and using our Websites so that we can tailor it to our customer base;
- To keep your account secure and protect our services, including to verify the identity of others to prevent fraud and abuse; and
- To contact you (unless you tell us that you prefer us not to) regarding features and functionality that may be of interest to you.

5. We rely on the following legal basis for processing your personal data:

- To pursue legitimate interests, including to carry out, monitor and analyse our business or operations;
- For purposes which are required by law and/or for the purpose of responding to requests by government, a court of law, or law enforcement authorities conducting an investigation in any country; and
- For any other purpose for which your personal data were provided to us.

Your provision of personal data to us is a contractual requirement. If you do not supply your personal data to us, it may delay or prevent us from providing you with our products or services (for example, we will not be able to provide you with brokerage services). If we cannot provide a product or service to you because you do not supply us with your personal data, we will notify you at the time.

6. Disclosing, sharing and transferring data

Within OTC, only those authorised to process your data can access your data. Your personal data may be shared to our affiliates, subsidiaries, and other third parties as follows:

- Your data is uploaded and stored on our EOX server which is located in Houston, TX, USA. This data can be accessed by OTC and other group companies based overseas;
- a third party provider which we use as part of delivering our brokerage services to you, such as Microsoft Outlook for storing emails and Oracle and Bluebook for payment purposes;
- our professional advisers (lawyers, accountants, financial advisers, etc.);
- regulators and government authorities in connection with our compliance procedures and obligations;
- a purchaser or prospective purchaser of all or part of our assets or our business, and their professional advisers, in connection with the purchase;
- a third party to respond to requests relating to a criminal investigation or alleged or suspected illegal activity;
- a third party, in order to enforce or defend our rights, or to address financial or reputational risks; and
- other recipients where we are authorised or required by law to do so.

7. How your data is kept secure

OTC makes every effort to protect against the loss, misuse and alteration of the data under our control. We employ a variety of physical and technical measures to keep your data safe and to prevent unauthorised access to, or use or disclosure of your personal data.

Your personal data is stored on a secure EOX server which is based in Houston, TX, USA. In order to protect your data, this server is password protected and only employees with admin rights can access, amend and add personal data for our clients.

In addition, we always use a secure connection when collecting financial data from your business (if required). We use the SSL (Secure Sockets Layer) protocol for encryption. Most web browsers (e.g. Microsoft Explorer, Mozilla Firefox, Safari, Google Chrome, etc.) support SSL.

We endeavour to ensure that any time data transferred outside the EEA is kept secure in accordance with the Data Protection Laws.

8. How we will communicate with you

We communicate with our clients by mobile calls and text messages, direct line calls and voice box (recorded lines), instant messenger, and email. We will send you email relating to your transactions with OTC and service-related announcements when it is necessary to do so. The Financial Conduct Authority (FCA), our Regulatory body, requires that we keep a record of our communications for a minimum of 5 years and maximum 7 years.

In terms of marketing, we want to communicate with you only if you want to hear from us. We try to keep emails to a minimum and give you the ability to opt in to any marketing communications we send.

You can decide not to receive communications or change how we contact you at any time. You can unsubscribe from our emails at any time through the unsubscribe link at the end of all our emails. 9. Data retention and storage

OTC's electronic data and databases are stored on a secure EOX server which is based in Houston, TX, USA. Therefore your data will be processed in the US. In order to protect your data, this server is password protected and only employees with admin rights can access, amend and add personal data for our clients.

We will only use and store data for so long as it is required for the purposes it was collected for. We will retain your data as long as your account is active, as necessary to provide you with the services or as otherwise set forth in this Policy. We will also retain and use this data as necessary for the purposes set out in this Policy and to the extent necessary to comply with our legal obligations, resolve disputes, enforce our agreements and protect OTC's legal rights.

10. Cookies

We use cookies on our Websites. Cookies are files which are downloaded to a device when certain websites are accessed by users, allowing the Website to identify that user on subsequent visits.

The only cookies in use on our Websites are for Google Analytics. Google Analytics are tools employed by organisations to help them understand how visitors engage with their website, so improvements can be made. Google Analytics collects data anonymously and reports overall trends without disclosing data on individual visitors. You can opt out of Google Analytics which will not affect how you visit our Websites.

All browsers allow you to control which cookies you accept and which you delete. You will usually find these settings under the 'Preferences' or 'Tools' menu of your browser. For detailed information on the cookies we use and the purposes for which we use them please see our Cookie Policy available at www.otcgh.com.

11. Marketing

With regard to marketing-related communication, we will - where legally required - only provide you with such data after you have opted in. We also provide you with the opportunity to opt out at any time if you do not wish to receive further marketing-related communication from us. We like to keep our customers, personnel and other interested parties informed of company developments, including news relating to OTC that we believe is of interest to them.

You also have choices about cookies, as described in Section 10 of this Policy. By modifying your browser preferences, you have the choice to accept all cookies, to be notified when a cookie is set, or to reject all cookies.

12. **Your Rights**

We want to ensure you remain in control of your personal data. Part of this is making sure you understand your legal rights, which are as follows:

- the right to confirmation as to whether or not we have your personal data and, if we do, to obtain a copy of the personal data we hold (You can submit a subject access request by requesting the necessary form by emailing GDPR@otceuro.com);
- the right to have your data erased (though this will not apply where it is necessary for us to continue to use the data for a lawful reason);
- the right to have inaccurate data rectified;
- the right to opt out of being included in Google Analytics;
- the right to object to your data being used for marketing or profiling; and
- where technically feasible, you have the right to personal data you have provided to us which we process automatically on the basis of your consent or the performance of a contract. This data will be provided in a common electronic format.

Please keep in mind that there are exceptions to the rights above and, though we will always try to respond to your satisfaction, there may be situations where we are unable to do so.
